Latour acquires All Sealing Solutions in Norway

Investment AB Latour (publ) has, through its subsidiary Specma Seals AB, signed an agreement to acquire the Norwegian company All Sealing Solutions AS from the company's founders and employees. The company is based in Sandnes, close to Stavanger in Norway, and a leading supplier of packing and gaskets, primarily to the oil and gas industry. The estimated revenue for 2015 is SEK 27 million and the company has 15 employees.

"All Sealing Solutions is a strong complement to Specma Seals, both geographically and industrially. Through the acquisition, we get a good position in the Norwegian market for packings and gaskets, but also an increased presence in the upstream segment, which entails exploration and production of oil and gas", says Krister Seleskog, CEO for Specma Seals.

"We are confident in the future together with Specma Seals, and believe that the two companies together will be an even more attractive supplier through the wide assortment and deep application know-how", says John Egil Ditlefsen, CEO of All Sealing Solutions.
